The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

*ARTICLE I - NAME*

The name of the Corporation is *TREMÉ TECHNICAL SERVICES, INC.*

*ARTICLE II - DURATION*

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

*ARTICLE III - PURPOSE*

The Corporation may engage in any activity or business permitted under the laws of the United States and under the laws of the State of Florida.

*ARTICLE IV - CAPITAL STOCK*

The Corporation shall have the authority to issue Ten thousand (10000) shares of common stock, in one class only, each having a par value of one dollar (\$1.00). Each of the said shares will entitle the holder thereof to one vote at any meeting of the shareholders.


## ***ARTICLE VIII - INDEMNIFICATION***
