ARTICLES OF INCORPORATION

ARTICLE ONE

The name of the corporation is CJ's Style 2000, Inc.

ARTICLE TWO

The period of its duration is perpetual. The effective date for the corporation shall be May 1, 2001.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
