The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation.

**Article I  
Name of the Corporation**

The name of the corporation is Grand Lifestyle Publisher Inc.

**Article II  
Principal Place of Business and Mailing Address**

The initial principal place of business and mailing address of the corporation shall be at 10375 SW 30 Street, Miami, FL 33165-2810

**Article III  
Purpose of the Corporation**

This corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

**Article IV  
Capital Stock**

The maximum number of shares of stock this corporation is authorized to have outstanding at any one time is ten million (10,000,000) shares of common stock at a \$1 par value each.

**Article V  
Indemnification**

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

**Article VI  
Term**

The corporation shall exist perpetually until dissolved by due process of law.

**Article VII  
Directors**

This corporation shall have at least one director initially. The number of directors may be changed from time to time in accordance with the bylaws adopted by the directors, but the number shall never be less than one (1).

**Article VIII  
Initial Registered Office and Agent**

**Article IX  
Incorporator**

The name and address of the incorporator of these Articles of Incorporation is Heinz Dinter, 10375 SW 30 Street, Miami, FL 33165-2810.

**Article X  
Preemptive Rights**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**Article XI  
Cumulative Voting**

At each election for directors, cumulative voting by shareholders as set forth in Florida Statutes, Chapter 607.097 (4) shall be allowed.
