Articles of Incorporation of Nathan Lane Bond, P.A.

The undersigned, for the purpose of creating a Professional Corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation: OLWAND SECTIONS

Article One

The name of the corporation shall be: Nathan Lane Bond, P.A.

Article Two

The principal place of business and mailing address of this corporation shall be:
