Articles of Incorporation of Nathan Lane Bond, P.A.

The undersigned, for the purpose of creating a Professional Corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

Article One

The name of the corporation shall be: Nathan Lane Bond, P.A.

Article Two

The principal place of business and mailing address of this corporation shall be:

Article Three

The primary purpose of the corporation is to provide professional services, as defined by Section 621.03(1), of the Florida Statutes. The corporation may do any and all lawful business for which a corporation may be incorporated under the laws of Florida.

Article Four

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of stock with a par value of \$1.00 each. Such stock shall be of a single class. No person may be a shareholder unless such person is an individual who is duly licensed or otherwise legally authorized to render the same specific professional services as those for which the corporation was incorporated. No shareholder of a corporation organized under this act shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of that person's stock.

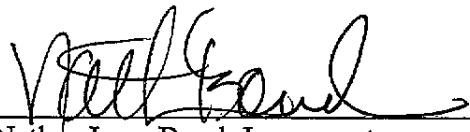

The duration of the corporation shall commence on May 7, 2001, and shall continue in perpetuity or until dissolved by law.

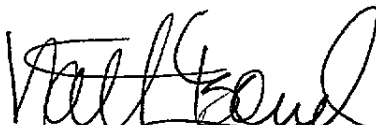
