**ARTICLES OF INCORPORATION**

THE UNDERSIGNED natural person, competent and licensed to practice certified public accounting in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation ("Corporation") for profit under the provisions of Section 607, Florida Business Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

1. **Name.** The name of Corporation is **BETH WATTS DOMINGUEZ, CPA, P.A.**

2. **Purpose.** The general nature and purposes of business to be transacted, promoted and carried on by the Corporation are as follows:

a. To engage in every aspect in the practice of the profession of certified public accounting, and all its fields of specializations, as are engaged in by certified public accounts.

b. To engage and render the professional services involved only through its officers, agents and employees who shall be certified public accountants in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this Corporation.

c. To invest Corporation's funds in real properties, mortgages, stocks, bonds, or any other types of investments, and while the owner or holder of any real properties, mortgages, stocks, bonds, or other type of investments, to receive, collect, reinvest, and dispose of the interest, dividends, and income arising from such property, and to possess and exercise all the rights, powers, and privileges of ownership, including all voting powers of any stocks owned.

d. To establish and carry out pension, profit-sharing, share-bonus, share-purchase, incentive, and benefit plans, trusts, and provisions for any or all of Corporation's Directors, officers, and employees.

e. Paragraphs 2(a) through 2(d) shall be construed as enumerating both objects and purposes of Corporation, and the enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of Corporation otherwise permitted by law.

f. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

3. **Principal Office Address.** The office of Corporation is to be located at 11997 S. US Highway 441, Belleview, FL 34421.

4. **Mailing Address.** The Corporation's mailing address is P.O. Box 2227, Belleview, FL 34421-2227.

5. **Duration.** The Corporation shall have perpetual existence.

6. **Capital Stock.** The aggregate number of common shares that Corporation shall have authority to issue is One Hundred Thousand (100,000) Common Shares, which shares are to have a par value of One Dollar (\$1.00) per share.

7. **Ownership Only by Qualified Persons.** The shares of capital stock of Corporation shall be issued and transferred (other than by operation of law or court decree) only to individuals who are authorized to practice as a certified public accounting in the State of Florida. No transferee of shares of capital stock of Corporation by operation of law or court decree may vote such shares for any purpose whatsoever except as permitted by the laws of Florida.

8. **Names and Qualifications of Shareholders.** The name, residence, and license or certificate number of the individual who is to be the original shareholder, Director, and officer of Corporation is:

This person is licensed by the State of Florida to practice the profession of public accounting.

9. **Severance and Termination of Employment.** If any officer, director, stockholder, agent or employee of this Corporation who has been rendering professional service to the public becomes disqualified to render the professional services for which the Corporation is organized, or accepts employment that places restrictions or limitations on this continued rendering of such professional services, he/she shall forthwith sever all employment with the Corporation, and shall not thereafter participate or share, directly or indirectly, in any earnings or profits realized by the Corporation on account of professional services. The Corporation shall forthwith, upon such disqualification of any shareholder, purchase such shareholder's shares and pay him/her all amounts owing and lawfully due to him/her by the Corporation, except that such shares shall not be entitled to dividends.

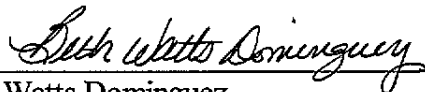
