The undersigned, acting as Incorporator(s) of R. Meunier & Son Contracting, Inc., a corporation under the Florida General Corporations Act, adopt(s) the following Articles of Incorporation for such corporation:

1. NAME: The name of this corporation is R. Meunier & Son Contracting, Inc., having its principal place of business at 2400 W. Broward Blvd., #1520, Ft. Lauderdale, Florida 33312.

2. DURATION: The period of its duration is perpetual.

3. PURPOSE: The purpose is to engage in general business.
