ARTICLES OF INCORPORATION OF
JEANNE BAKER, ATTORNEY AT LAW, P.A.

The undersigned subscriber, Jeanne Baker, a natural person competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation.

Article I. Name. The name of the corporation is **JEANNE BAKER, ATTORNEY AT LAW, P.A.**

Article II. Place of Business and Mailing Address: The principal place of business is: 2937 SW 27th Avenue, Suite 202, Miami, FL 33133. The mailing address is the same: 2937 SW 27th Avenue, Suite 202, Miami, FL 33133.

Article III. Purpose. The corporation may engage in any activity of business permitted under the laws of the United States and of the State of Florida. The corporation will specifically engage in the practice of law.

Article IV. Shares & Capitalization. The aggregate number of shares which the corporation shall have the authority to issue shall be five hundred (500) which shall be only one class. All issued stock shall be held of record by not more than ten persons. Each stock shall have a par value of One Dollar (\$1.00). All stocks shall be common stock and shall be issued and transferable only to natural persons who are not non-resident aliens of the United States. The amount of capital with which this corporation will begin business is Five Hundred Dollars.

Article V. Directors & Officers. The number of directors constituting the initial Board of Directors is one, to-wit: Jeanne Baker. The number of directors may be increased or reduced from time to time by By-Laws adopted by the stockholders but shall never be more than three or less than one. The initial officers of the corporation to serve until the next election of officers will be as follows:

Vice President: Jeanne Baker

Article VII. Amendments. These Articles of Incorporation may be amended in the manner approved by law. Every Amendment shall be approved by the Board of Directors, proposed by them to the stockholders entitled to vote thereon, unless all of the Directors and stockholders sign a written statement manifesting their intention that a certain amendment to the Article of Incorporation be made.

Article VIII. Incorporator. The name, post office address, number of shares of stock agreed to be taken and the value and consideration therefore for each incorporator is: Jeanne Baker, 2937 SW 27th Avenue, Suite 202, Miami, Florida 33133; 500 shares with a total consideration of \$500.00.
