The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

Article I

Name

The name of the corporation is Sam Sport Motif, Inc., and the principal address shall be, 1403 Moffett St., Hollywood, Fl. 33020

Article II

Duration

The Corporation shall exist perpetually.
