ARTICLE I NAME/ADDRESS

The name of this corporation is RENT-A-FIREFIGHTER, INC., the principal office of the corporation and mailing address is 5540 S. W. 90th Terrace, Cooper City, Florida 33328.

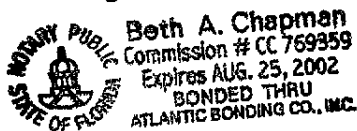
