**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Association is GLORIA BULLMAN, Psy.D, P.A. (the "Association").

ARTICLE II - DURATION

The Association shall have perpetual existence commencing on the date of filing these Articles with the Department of State.

ARTICLE III - PURPOSE & POWERS

The Association is organized for the purpose of rendering professional services in the practice of psychology and psychotherapy and, in furtherance thereof, of exercising any and all powers allowed to a lawful business corporation under Chapter 607, Florida Statutes, as it now exists or may hereafter be amended.

ARTICLE IV - CAPITAL STOCK

The Association is authorized to issue One Thousand (1,000) shares of common stock having no par value, which shall be designated as "Common Shares." In accordance with the limitation contained in Section 621.09(1), Florida Statutes (2000), the Association shall not issue any of its capital stock to anyone other than a professional corporation, a professional limited liability company, or an individual who is duly licensed or otherwise legally authorized to render the same specific professional services as those for which the corporation was incorporated. No shareholder of a corporation organized under this act shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of that person's stock.

ARTICLE V - PRINCIPAL PLACE OF BUSINESS; INITIAL REGISTERED OFFICE AND AGENT

The street address of the principal place of business of the Association is 7350 Sandlake Common Boulevard, Suite 2205, Orlando, FL 32819. The initial registered office of the Association is 2265 Lee Road, Suite 103, Winter Park, FL 32789, and the name of the initial registered agent of the Association at that address is Richard Spice Wheeler, Esq.

ARTICLE VI - INCORPORATOR

The name and address of the Incorporator signing these Articles is Richard Spice Wheeler, Esq., 2265 Lee Road, Suite 103, Winter Park, Florida 32789.

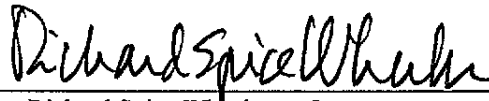
ARTICLE VII - INDEMNIFICATION

ARTICLE VIII - AMENDMENT

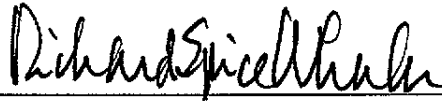

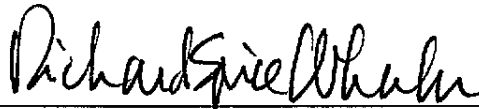
