ARTICLES OF INCORPORATION
OF
E.C.F. CLEANING CORPORATION

ARTICLE I - NAME

The name of this Corporation is E.C.F. CLEANING CORPORATION

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on May 1, 2001.
