ARTICLES OF INCORPORATION

CARPET SALES SERVICES INC.

ARTICLE I

THE NAME OF THIS CORPORATION SHALL BE:

CARPET SALES SERVICES INC.

ARTICLE II

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

ARTICLE III

THIS CORPORATION IS ORGANIZED FOR THE FOLLOWING PURPOSES:

- A. TO ENGAGE IN CARPET SERVICES OF ANY TYPE OR NATURE
TO SEE, OR TRADE ALL ITEMS RELATIVE TO CARPET SALES
- B. TO BUY, SELL, TRADE, DEAL IN, LEASE, OPERATE, HOLD OR

INCIDENT THERETO OR CONNECTED THEREWITH, AND TO ACQUIRE

HEREDITAMENTS, OR ANY INTEREST THEREIN AND TO HOLD, MAN-
AGE AND DEAL IN ALL SUCH PROPERTY.
- C. TO MAKE AND ENTER INTO CONTRACTS AND TO CARRY OUT CON-
TRACTS OF EVERY KIND FOR ANY LAWFUL PURPOSE AND TO PLEDGE,
MORTGAGE OR OTHERWISE ENCUMBER PROPERTY OF THE CORPORATION;
- D. TO DO ANY AND ALL THINGS IN CONNECTION WITH THE OPERATION
OF IT'S BUSINESS AND TO HAVE ALL THE POWERS CONFERRED BY
BY THE LAWS OF THE STATE OF FLORIDA UPON CORPORATIONS
ORGANIZED UNDER THE LAWS THEREOF.
- E. FOR THE PURPOSE OF ENGAGING IN ANY AND ALL LAWFULL BUSINESS.

HE ALREADY HOLDS, SHALL HAVE THE RIGHT TO PURCHASE HIS PRO-RATA
SHARE THEREOF AT THE SAME PRICE AT WHICH IT IS OFFERED TO OTHERS.
