My bookkeeper departed to go back to college, and my accountant decided it was too far to travel to Carrollwood, and I guess my preoccupation with other issues has impacted her willingness to continue to serve our needs. I began using another accountant, whom I believed was filing these forms on my behalf, as my former accountant had done. This was not the case and a new assistant revealed to me after the due date the need to file this form.

I ask your forbearance under the circumstances and request you abate the penalties involved here. I am normally diligent about my business and the needs of the bodies that govern, and there is no disrespect nor negligence involved here. I was simply focused on trying to keep my parents safe and well and overcome the illness that plagued my Father.
