

ARTICLES OF INCORPORATION

OF

<u>ARTICLE I - NAME</u>

The name of this corporation is U.S COACHWORKS, INC., and the mailing address shall be 13899 Biscayne Boulevard, Suite 311, North Miami Beach, Florida 33181.

ARTICLE II - DURATION

This corporation is to exist perpetually.

ARTICLE III - PURPOSE


