The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Jorge Leal Enterprises, Inc.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on May 8, 2001 and shall exist perpetually unless sooner dissolved according to law.


ARTICLE VIII - SHAREHOLDER PROPERTY
