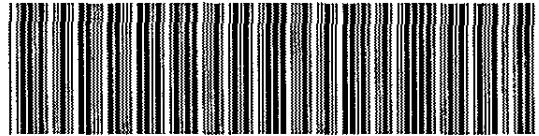

FIRST: Article I of the Articles of Incorporation is amended:


ARTICLE I - NAME


