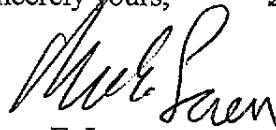

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is: American Plan Designs, Inc.

**ARTICLE II**

The existence of the Corporation shall be perpetual and shall begin on the date these articles are filed with the Florida Department of State.

**ARTICLE III**

The street address of the principal office of the Corporation is: 13776 Lilac Place, Wellington, Florida 33414.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 10,000, all of which shall be Common Shares, with a par value of \$.01 per share.
