ARTICLES OF INCORPORATION OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby binds himself to form a corporation under the laws of the State of Florida

ARTICLE I Name.

The name of the corporation shall be:

4. **ARTICLE IV TERM**

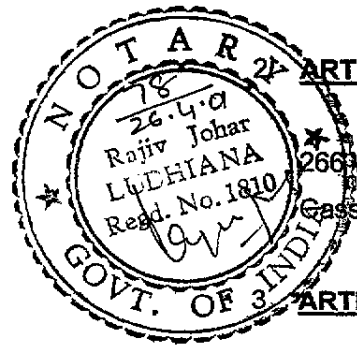
This corporation shall have perpetual existence.

This corporation shall have two directors initially. The number of directors may be increased or diminished from time to time by the By-Laws. The name and address of the initial directors are:

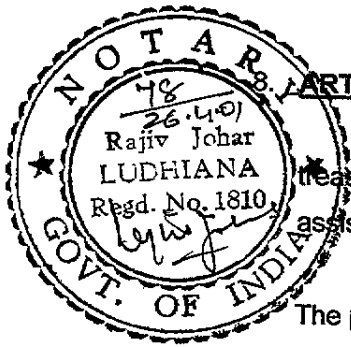

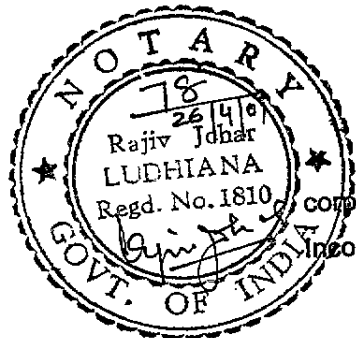
