ARTICLE I

NAME

Platinum Plus Records, Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 1813 Plantation Oaks Drive, Jacksonville, Florida 32223.

ARTICLE III




