OF

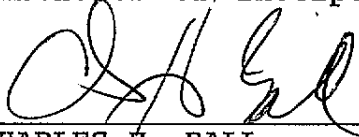

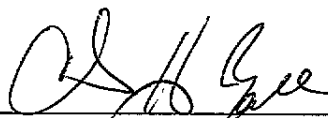
