# ARTICLES OF INCORPORATION

### ARTICLE I - NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this corporation is DOCS LAND CORP, Inc. and its principal place of business shall be located at 212 South Florida Street, Bushnell, Florida 33513.

### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with The Department of State.

### ARTICLE III - PURPOSE

This corporation is organized for the purpose of medical administration and to conduct any other lawful business.

### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue Five Hundred (500) shares of common stock at One Dollar (\$1.00) par value, which shall be designated as "Common Shares".

### ARTICLE VII - DIRECTORS

Initially, this corporation shall have one (1) Director who shall serve until her successor shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than one (1) director constituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the Bylaws.

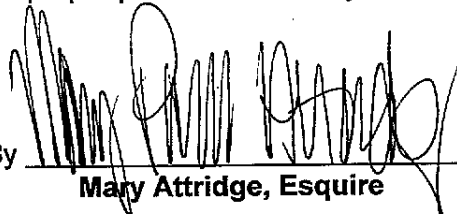
