ARTICLES OF INCORPORATION OF AZTEC EXPRESS, INC.

If the interest of such director or directors, is, or was, necessary for the approval of such contract or transaction, then such contract or transaction shall, with disclosure of the director's or director's interest, be submitted for the approval of or ratification by the stockholders.
