GENERAL AUTHORITY

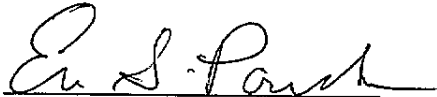
The corporation shall have power to purchase or otherwise acquire, directly and or through ownership of a stock in any corporation, all or any part of the business, goodwill,

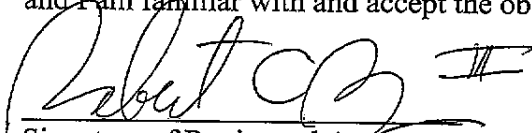
