The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation shall be Bangkok Distributors, Inc.

**ARTICLE II - COMMENCEMENT & DURATION**

The corporation shall commence its existence on May 11, 2001 and shall exist perpetually unless sooner dissolved according to law.
