ARTICLES OF INCORPORATION OF

LEROY'S TRACTOR SERVICE, INC.

The undersigned subscriber to these Articles of Incorporation, is a natural person competent to contract, and hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is: LEROY'S TRACTOR SERVICE, INC.

ARTICLE II. PERMITTED BUSINESSES AND ACTIVITIES

The general nature of the business to be transacted by this corporation is to engage in all phases of tractor work and mowing. This corporation may engage in every phase of any and all activities or businesses permitted by the laws of the United States and the State of Florida or any other state, territory, district, or possession of the United States and all such activities or businesses as may be permitted in any foreign country. Without limiting the generality of the foregoing, the corporation shall have power to:

- Conduct business, have one or more offices, and buy, hold, mortgage, sell, convey, (a) lease or otherwise dispose of real and personal property, and buy, hold, mortgage, sell, convey, or otherwise dispose of franchise in this state and in any of the several states, territories, possessions and dependencies of the United States, the District of Columbia, and in foreign countries.
- Purchase the corporate assets of any other corporation and engage in the same (b) character of business.
- Acquire, enjoy, utilize and dispose of patents, copyrights and trade marks and any (c) licenses or other rights or interests thereunder or therein.
- (d) Take, hold, sell and convey such property as may be necessary in order to obtain or secure payment of any indebtedness or liability to it.
 - (e) Guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise

The foregoing clauses are both purposes and powers; and the foregoing enumeration of specific powers does not limit or restrict in any manner the powers of the corporation.

This paragraph shall not be construed to invalidate any contract or other transaction that would otherwise be valid under the common or statutory law applicable thereto.
