THE UNDERSIGNED, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be Custom Aero, Inc.. The principal office and mailing address of the corporation is 1440 SW 28th Avenue, Pompano Beach, Florida 33069.

ARTICLE II DURATION

The term of existence is perpetual.

ARTICLE III CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is One Thousand (1,000) shares and each share shall be the par value of One (\$1.00) Dollar. The stock of this corporation shall be common stock and shall be fully paid and non-assessable.
