ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

EFFECTIVE DATE

ARTICLE I - NAME

05/01/01

The name of this corporation is M. TACHIBANA FINANCIAL SERVICES, INC.

ARTICLES II - PURPOSE

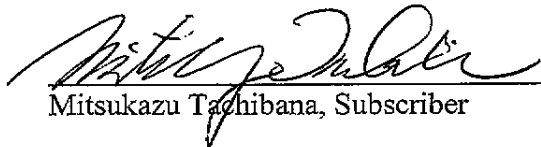
