PROPOSED CHARTER

FOR

BT MUSIC NET, INC.

TALLAHASSEE, FLORIDA

We, the undersigned persons, hereby present ourselves

for the purpose of forming a corporation under the laws of

the State of Florida, and do hereby adopt the following

Articles of Incorporation, and make application for charter

in accordance with same.

ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation shall be BT MUSIC NET,

ARTICLE II

The general nature of the business to be transacted shall be as follows:

To engage in such businesses and transactions as may be permitted under the laws of the State of Florida, including production of audio compact discs containing original music for use in business establishments providing background or mood music, as well as presentation of a variety of music programming, recording and performance, and to conduct

business activities and services related thereto, contract
for, sell and purchase of real and personal property, stock
and intangible property, apply for, obtain and own
