#### ARTICLES OF INCORPORATION

The undersigned incorporator adopts these articles of incorporation for the purpose of forming a professional corporation under Chapters 607 and 621 of the laws of the State of Florida.

### ARTICLE I. NAME

The name of the corporation shall be John S. Srabian, DDS, PA. The street address of the initial principal place of business and the initial mailing address of this corporation shall be 14871 Lake Olive Drive, Fort Myers, FL 33919.

#### ARTICLE II. NATURE OF BUSINESS

This corporation is formed:

- (a) to engage in every aspect in the practice of dentistry;
