
ARTICLE VIII - INDEMNIFICATION



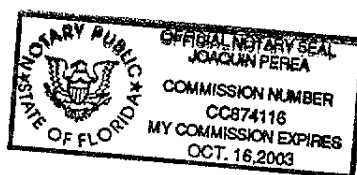


