ARTICLE I. CORPORATE NAME

ARTICLE VI. DURATION OF CORPORATION

The duration of the Corporation shall be perpetual.

ARTICLE VII. PRE-EMPTIVE RIGHTS

Each shareholder of the Corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in the Corporation that may from time to time be issued (whether or not presently authorized) including shares from the treasury, in the ratio that the number of shares he/she holds at the time of issue bears to the total number of shares outstanding. ARTICLE IX. AMENDMENTS

Any amendment of the Articles of Incorporation of the Corporation shall require a minimum two-thirds (2/3) vote of the shareholders.

Any amendment of the Bylaws of the Corporation shall require a minimum two-thirds (2/3) vote of the shareholders.

This right to vote cumulatively shall not be further restricted or qualified by any provision in the Bylaws of the Corporation.
