**ARTICLES OF INCORPORATION**  
**OF**  
**LISA'S CLEANING, INC.**

Articles of Incorporation executed by the undersigned for the purpose of forming a corporation under the Florida Business Corporation Act.

**ARTICLE I**

The name of the Corporation shall be Lisa's Cleaning, Inc. and the initial address of this Corporation shall be 1502 SW 39<sup>th</sup> Terrace, Cape Coral, Florida, 33914.

**ARTICLE II**

The Corporation shall have all of the common law and statutory powers and duties of a Corporation for profit under the laws of the State of Florida, except as limited or modified by these Articles or Bylaws.

**ARTICLE III**

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

10,000	\$10.00	Common

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors in the Corporation.

**ARTICLE IV**

This Corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

#### **ARTICLE V**

The initial registered office of this Corporation shall be at 1502 SW 39<sup>th</sup> Terrace, Cape Coral, Florida, 33914 with the privilege of having its offices and branch offices at other places within or without the State of Florida. The initial registered agent at that address shall be Lisa Runge.
