ARTICLE I. NAME

The name of this corporation shall be Peace River Tropicals, Inc.

ARTICLE II. COMMENCEMENT AND DURATION

The commencement of this corporation's existence shall be effective May 7, 2001. This corporation's duration shall be perpetual.






