The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: INLINE-CONSTRUCTION OF FLORIDA, INC. The principal place of business will be 8039 Diagonal Rd. North, St. Petersburg, FL 33702-3645.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE
