

THE UNDERSIGNED, acting as sole incorporator of ENCORE PERFORMING ARTS CENTER, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE III


Principal Office

Initial Board of Directors


