The undersigned does hereby execute, acknowledge and file the following Amendment to the Articles of Incorporation of MVC SERVICES INC.

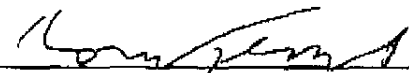
1. The name of the corporation is currently MVC SERVICES INC.
2. The Articles of Incorporation are amended as follows:
 - a. By deleting, immediately preceding the first paragraph of such Articles, the word, "MVC Services." and by substituting in lieu thereof "Hake Inc."; and
 - b. By deleting all of Article I hereof, and by substituting in lieu thereof, all of the following:

The name of this corporation shall be: Hake Inc.
 - c. In all other respects, the Articles of Incorporation shall remain unchanged.
3. This Amendment was adopted and approved by a written statement signed by all the shareholders of this Corporation on July 23, 2003, pursuant to Section 607.1006 of the Florida Statutes, and the number of votes cast for the amendment was sufficient.
