PLAN OF MERGER

PLAN OF MERGER, dated _____,2001 between STANTON MAGNETICS ENT., LLC, a Florida Limited Liability Company (the "Merging Company") and STANTON MAGNETICS, INC., a Florida corporation (the "Surviving Corporation").

The Merging Company and the Surviving Corporation desire to effect the statutory merger of the Merging Company and the Surviving Corporation, and the Surviving Corporation shall survive such merger, as follows:

- Merging Company. The Merging Company shall be party to the merger ("Merger") with and into the Surviving Corporation
- 2. Terms and Conditions of Merger. The Merging Company, pursuant to the provisions of the Florida Business Corporation Act and the Florida Limited Liability Company Act, shall be merged with and into the Surviving Corporation. On the Effective Date, the Surviving Corporation shall assume the rights, privileges and obligations of the Merging Company.
- 3. Capital Stock: Conversion of Shares. Upon the Effective Date, the Merging Company's membership certificates presently issued and outstanding, shall be retired. Upon the Effective Date, each issued and outstanding share of the Surviving Corporation's Common Stock shall remain issued and outstanding.
- 4. Articles of Incorporation. The Articles of Incorporation of the Surviving Corporation as of the Effective Date shall be the Articles of Incorporation of the Surviving Corporation and shall continue in full force and effect until changed, altered or amended as therein provided and in the manner prescribed by the laws of the State of Florida.
- Bylaws. The Bylaws of the Surviving Corporation as of the Effective Date shall be the Bylaws of the Surviving Corporation and shall continue in full force and effect until changed, altered or amended as therein provided and in the manner prescribed the laws of the State of Florida.
- Officers and Officer. The Directors and Officers of the Surviving Corporation in office on the Effective Date shall continue to be the Directors and Officers of the Surviving Corporation, all of whom shall hold their directorships and offices until the election and qualification of their respective successors or until their tenure is otherwise terminated in accordance with the Bylaws of the Surviving Corporation.
