ARTICLES OF INCORPORATION

OF

DANCER TRUCKING INC.

The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

ARTICLE I

DANCER TRUCKING INC.

DURATION

The corporation shall have perpetual existence with an effective commencement date of June 1st 2001.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are:

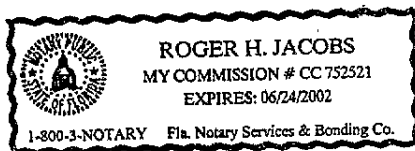
