# ARTICLES OF INCORPORATION

FOR

A J PRESSURE CLEANING SERVICES, AND

ARTICLE I

The name of this corporation is A J PRESSURE CLEANING SERVICES, INC.

### ARTICLE II

This corporation is organized for the purpose of engaging in and transacting any lawfull business permitted under the laws of the United States and the State of Florida. The principle business activity of this corporation is cleaning services.

#### ARTICLE III

The term for which this corporation shall exist shall be perpetual.
