ARTICLE I

The name of this corporation is OLGA ERIKHMAN-WARREN.

ARTICLE II

This corporation is organized for the purpose of engaging in and transacting any lawful business permitted under the laws of the United States and the State of Florida. The principle business activity of this corporation is real estate services.

ARTICLE III

The term for which this corporation shall exist shall be perpetual.

ARTICLE IV


