**ARTICLE I**

**CORPORATE NAME AND PRINCIPAL OFFICE**

**ARTICLE II**

**BOARD OF DIRECTORS**

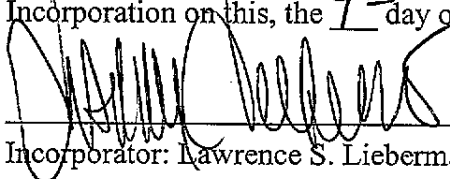

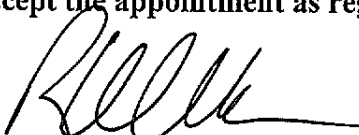

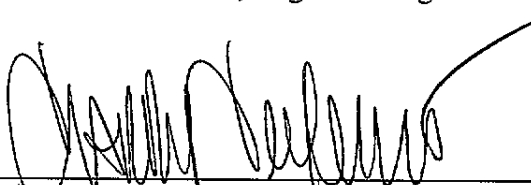
