ARTICLES OF INCORPORATION  
OF

International Renal Institute & School, Inc.

The undersigned, acting as incorporator of International Renal Institute & School, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. Name

The name of the corporation is: International Renal Institute & School, Inc.

ARTICLE II. Address

The mailing address of the corporation is 661 S.E. 5<sup>th</sup> Avenue, Pompano Beach, Florida 33060.

ARTICLE III. Commencement of Existence

The existence of the corporation will commence on the filing of these Articles of Incorporation.

ARTICLE IV. Purpose

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. Authorized Shares

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE VI. Initial Registered Office and Agent

The street address of the initial registered office of the corporation is 1320 S Dixie Highway, Suite 811, Coral Gables, Florida 33146 and the name of the corporation's initial registered agent at that address is Robert M. Mayer, Esq.

ARTICLE VII. Initial Board of Directors

The corporation shall have one director initially. The number of directors may be either increased or diminished from time to time, as provided by the bylaws, but shall never be less than one. ARTICLE VIII. Incorporator

The incorporator of the corporation assigns to this corporation his rights under Section 607.0201, Florida Statutes, to constitute a


ARTICLE IX. Bylaws


