**ARTICLE I  
NAME**

**ARTICLE II  
DURATION**

This corporation shall exist perpetually.


**ARTICLE VIII**

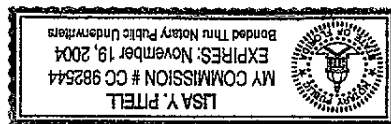




