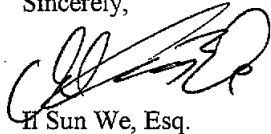

ARTICLES OF INCORPORATION
OF
Y. K. GROCER, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Y. K. GROCER, INC.

ARTICLE II

The purposes for which the Corporation is formed are to engage in restaurant business, and to engage in any other lawful purpose and business.

ARTICLE III

The street address of the principal office of the corporation is 2350 Montclair Road, Leesburg, Florida 34748.

ARTICLE IV

The maximum number of shares this corporation is authorized to issue is 1,000,000 with \$1.00 par value, all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 2350 Montclair Road, Leesburg, Florida 34748.

No director or officer of the Corporation shall be liable to the Corporation or to its stockholders for money damages except (1) to the extent that it is proved that such director or officer actually received an improper benefit or profit in money, property or service, for the amount of the benefit or profit in money, property or service actually received, or (2) to the extent that a judgment or other final adjudication adverse to such director or officer is entered in a proceeding based on a finding in the proceeding that such director's or officer's action, or failure to act, was (a) the result of active and deliberate dishonesty, or (b) intentionally wrongful, willful or malicious and, in such case, was material to the cause of action adjudicated in the proceeding.
