**ARTICLES OF INCORPORATION
OF
MARGARET H. RINKER, M.D., P.A.**

The undersigned, acting as incorporator of a corporation under the Florida Professional Service Corporation Act, adopts the following articles of incorporation for such corporation:

**ARTICLE I
Name**

The name of the corporation is: Margaret H. Rinker, M.D., P.A.

**ARTICLE II
Mailing Address**

The mailing address is: 2625 North Dundee Street, Tampa, Florida 33629.

**ARTICLE III
Nature of Business**

The Corporation is organized to engage in every aspect of the business of rendering the professional medical services to the public that a physician, duly licensed under the laws of the State of Florida, is authorized to render, but such professional medical services shall be rendered only through officers, employees, and agents of the Corporation who are duly licensed under the laws of the State of Florida to render such services, and to engage in any and all other lawful business.

**ARTICLE IV
Stock**

The Corporation shall have authority to issue 1,000 shares of \$.01 par value common stock.


ARTICLE VIII
