**ARTICLES OF AMENDMENT TO THE ARTICLES OF
INCORPORATION OF
VELEZ REPAIR SHOP, INC.**

Pursuant to Chapters 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of **VELEZ REPAIR SHOP, INC.**, a Florida corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is **VELEZ REPAIR SHOP, INC.**

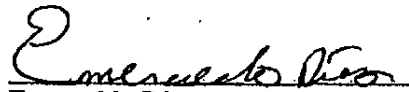
SECOND: **ARTICLE I.** of the Articles of Incorporation is amended in its entirety as follows:
