The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

# ARTICLE I NAME

The name of the corporation shall be SANIBEL BIOLOGICAL SUPPLY, INC.  $\,$ 

### ARTICLE II PRINCIPAL OFFICE

The street address of the principal office is 13796 Waterfront Drive, Pineland, Florida 33945, and mailing address of this corporation shall be P.O. Box 486, Pineland, Florida 33945.

### ARTICLE III CAPITAL STOCK
