**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of RICKENBACKER CONSTRUCTION, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is RICKENBACKER CONSTRUCTION, INC. (the "Corporation").


ARTICLE VIII. BYLAWS


