ARTICLES OF INCORPORATION OF

UNIVERSAL THERAPY & REHABILITATION CENTERS, INC.

We, the undersigned, being of legal age, do hereby associate form the purpose of becoming a corporation under the laws of the state of Florida authorizing the formation of corporations.

The general nature of the business and the object and purposes proposed to be transacted and carried on are to engage in and all activities or business permitted under the laws of the United States and the State of Florida.
